Entry Deadline: May 28, 2019, before 5 PM

Juror: Stephen Edwards, Emeritus Professor of Art, Alfred University in New York. See his artwork at <https://americanart.si.edu/artist/stephen-dee-edwards-1415>.

Awards: Three cash Jurors' Awards will be selected following installation. Awards will be announced at the opening reception on August 2 at 7 PM.

Eligibility: Open to all current SLOMA and Central Coast Sculptors Group (CCSG) members. To join, visit sloma.org.

Entry Fee: There is no entry fee for this exhibition.

Submissions may be made via one of the following methods:

Option 1: EMAIL your filled out Entry Form (see writable pdf below) and up to three JPEG images (max 1800 pixels wide) to Info@sloma.org with *The 3rd Dimension* in the subject line.

Option 2: Mail a CD or flash drive and completed entry form to:

Option 3: Hand Deliver your entry form and image files on CD or flash drive to SLOMA at 1010 Broad Street, San Luis Obispo, CA, between 11 AM and 5 PM.

The Juror will select artworks from JPEG images supplied by the artists. Each JPEG image must be labeled with the artwork title, medium, and dimensions (height, width, depth) only. (example: Spring Has Sprung.18x24x4.jpg). Images should be at no larger than 1800 pixels on the longest side. JPEG title must match the title on your entry form.

Sales: Sales are encouraged, but are not required. Prices set by the artists may not be changed after acceptance. Your sales price should include 50% commission to SLOMA. All artwork will remain in the exhibition through September 29, 2019.

Insurance and Liability: SLOMA and CCSG representatives will make every reasonable effort to protect artwork from the time it is received until it is returned. However, neither

SLOMA nor CCSG will be held responsible for any damage or theft of artwork. Artists may wish to insure their artwork.

Submission to this exhibition constitutes an agreement on the part of the entrant to listed conditions and the use of images for publicity purposes. SLOMA and the CCSG reserve the right to not display work inconsistent with juried images.

Delivery of Artwork: Shipping instructions will be sent to artists whose artwork has been accepted into the exhibition. Please note: artists who ship artwork must include a \$25 check to SLOMA for the storage and handling fee.

The accepted artworks will be installed in the SLOMA McMeen gallery. It is on the 2nd floor of the Museum, and has a standard size 30” doorway entrance. There is no elevator. If the artwork weighs more than 75 pounds, the artist must be present to help during the installation.

Shipped artwork must also include a paid UPS or FedEx barcode return shipping label within the shipping box. For any artwork without a return shipping label, SLOMA will not be responsible for return shipping, and the artist must make other arrangements.

Pick Up / Return: Hand-delivered artwork should be picked up on Monday, September 30, 2019, 11 AM – 5 PM, or by special appointment. Shipped artwork will be returned no later than mid-October. Sold artwork will be shipped at buyer’s expense.

Submission of artwork to this exhibition constitutes an agreement to the conditions stated in this Call For Entry and a commitment to show accepted artwork for the duration of the exhibition. By entering this exhibition, artists agree to allow CCSG and SLOMA to use submitted images in promotional material. SLOMA reserves the right to reject any artwork that does not meet the standards shown in the images supplied. No substitutions are allowed.

Timeline for Exhibition Dates and Deadlines

- May 28: Entry Deadline
- July 14: Notification of acceptance and non-acceptance by email only
- July 30: Deadline for delivery of artwork to SLOMA between 11 AM and 5 PM
- Friday August 2: Opening Reception, 6–9 PM with Art After Dark. Awards at 7 PM
- Friday September 6: Second Reception, 6–9 PM with Art After Dark
- September 29: Exhibit ends at 5 PM
- September 30: Pick up unsold artwork Monday, 11 AM to 5 PM
- Unsold shipped artwork will be repackaged and returned to artists at close of exhibition. Sold artwork will be shipped to buyer at buyer’s expense. SLOMA cannot store artwork.
