**Eligibility:** *Brushstrokes 2020* is a non-themed annual exhibition of The Painters Group (TPG), representing a wide range of artistic expression in painting. *Brushstrokes 2020* is open to members in good standing of The Painters Group, San Luis Obispo Museum of Art (SLOMA), or Morro Bay Art Association.

**Juror: Marcia Harvey**

Marcia Harvey holds a BA in Studio Art from the University of California and an MFA in Fine Arts from Washington State University. She is currently on the Faculty of Cuesta College in San Luis Obispo and teaches Printmaking. She has exhibited her work widely and has won awards in juried competition. She is an author and blogger. She says of her paintings, "These works are still lifes and landscapes, field notes and occasions, letters and witnessings. Like the painters of 17th Century Dutch still lifes, I am interested in illustrating mundane objects with a care and regard for them, and an emphasis on the transitory nature of life."

**Awards:** Three paintings will be chosen for cash prizes and the Juror's Award of Excellence. Vendor and material awards also will be presented.

**Submission Details:** The Juror will select paintings from digital images supplied by artists via online submission only.

Eligible artists may submit images of 1-2 paintings for a fee of \$35, or 3 images of paintings for \$45. Entry fees are non-refundable. If accepted, only one painting per artist will be allowed.

Each JPEG image must be labeled with the painting title and dimensions (height first) and no artist's name (e.g. BlueSky.16x20.jpg.) Images should be a minimum of 900 pixels and no larger than 1800 pixels on the longest side.

To enter Brushstrokes 2020, go to the San Luis Obispo Museum of Art's website, <https://sloma.org/exhibits/call-for-artists>, to **Call For Entry: Brushstrokes 2020** and follow the instructions in the SLOMA entry process. You will be asked to submit your images, provide information, and pay via credit card. Please keep a copy of this application for your records.

Notification of acceptance or non-acceptance will be made via e-mail by February 3, 2020.

**Agreement:** Submission of artwork to this exhibition constitutes an agreement to the conditions stated in this Call For Entry and a commitment to show accepted art for the duration of the exhibition. By entering this exhibition, artists agree to allow TPG, SLOMA, and ACMB to use submitted images in promotional material.

The Juror and TPG representatives reserve the right to reject any painting that does not meet the standards shown in the images supplied. No substitutions are allowed. To be exhibited, paintings must be framed (unless on panel or gallery wrapped canvas), securely wired, and ready to hang. No sawtooth hangers are allowed.

**Requirements:** Paintings previously exhibited at SLOMA, ACMB, or in any past exhibition of TPG are not eligible. Paintings previously exhibited

in the Phantom Project are eligible. Wall-hung artwork must not exceed 48 inches (framed) in either height or width. Paintings must have been completed within the past three years and may be in any painting medium including digital. No prints or giclées will be accepted.

**Prices, Sales, and Commission:** All paintings must be for sale. ACMB will handle all sales and retain a 25 percent commission. Artists will receive 75 percent of the sales price of the work. Prices set by the artists may not be changed after entry.

**Insurance and Care:** Artists are encouraged to carry their own insurance. SLOMA, TPG, and ACMB representatives will make every reasonable effort to protect art from the time it is received until it is returned to the artists. SLOMA, TPG, ACMB, and their members will not be held responsible for any damage or theft of paintings.

**Delivery:** Accepted paintings must be hand delivered to Art Center Morro Bay, 835 Main Street, Morro Bay, CA 93442 on Tuesday, March 31, 2020 between 10 AM and 2 PM. **No shipping is allowed for this exhibition.**

**Pick Up:** Unsold paintings must be picked up on Tuesday, May 12, 2020, between 10 AM and 2 PM.
