**Juror: Julie Dunn** holds a BA degree in drawing and painting from Cal State Fullerton and a teaching credential in Art Education from National University. Her art career has spanned over 35 years and includes graphic design, architectural illustration, textile art-to-wear, mural design, and painting. Dunn co-owned L'Artiste Gallery for 3 years followed by the Gallery at the Network for 15 years, both located in San Luis Obispo. She currently co-owns the Park Street Gallery in Paso Robles.

Awards: Three cash Jurors' Awards will be selected following installation.

**Eligibility:** Open to all current Central Coast Craftmakers members. (To join visit <u>SLOMA.org.</u>)

**Entry Fee:** Current Central Coast Craftmakers members may enter up to three artworks via the online entry form for a non-refundable entry fee of \$40.

#### Application Entry Procedure:

We have a new online entry process using the SLOMA website. Visit <u>https://sloma.org/exhibits/call-for-artists/</u>. You will enter your contact and artwork

information, then upload your jpeg images, then pay your entry fee with a Visa, MasterCard or American Express. No physical entry forms or checks will be accepted.

**IMPORTANT!!!!** Please double check the online form before hitting the "Add to Cart" button. You **cannot** edit the form after it has been added to your Cart. If you find you have made a mistake after adding the entry form to your Cart, you will need to remove the entry form from your Cart (red X to the left of the item listing) and fill out the form all over again.

**DO NOT** submit multiple copies of the form as it will result in multiple charges to your credit card. Always check the number of items in your cart **AND** the total to be charged <u>before</u> submitting payment.

#### **Entry requirements:**

1. Each jpeg must be labeled with title and dimensions. For example, "Spring Has Sprung 12x12x1." NO artist name or other info. The title of the jpeg **MUST** match the title on the entry form.

2. Entry Deadline: Your online entry and payment, must be **received** by December 1, 2019.

3. Artworks previously exhibited at SLOMA or in any past exhibition of Craftmakers are not eligible. Artworks exhibited in *Phantom Projects* at SLOMA's Pop-Up Galleries are eligible. Artwork must not exceed 16 inches in height or width, and no more than 4 inches in depth, nor weigh more than 25 pounds.

4. Artwork must have been completed in the past three years and may be in any fine craft media.

**5.** Sales are encouraged, but are not required. Prices set by the artists may not be changed after acceptance. Your sales price should include 40% commission to SLOMA.

6. Artwork must be prepared for exhibition.

7. SLOMA and Craftmakers representatives will make every reasonable effort to protect artwork from the time it is received until it is returned. However, neither SLOMA nor Craftmakers will be held responsible for any damage or theft of artwork. Artists may wish to insure their artwork.

**Notification** of acceptance or non-acceptance will be made via e-mail only. If you have not received notification by December 23, 2019, you may contact the Museum by phone or by emailing Courtney Davis at <u>cdavis@sloma.org</u>. **Delivery of Artwork:** Accepted artwork must be hand delivered to the San Luis Obispo Museum of Art, 1010 Broad St., San Luis Obispo, CA 93401 on Tuesday, February 4, 2020, before 5 PM. Shipped artwork should arrive by Monday, February 3.

**NOTE:** There is a \$25 handling and storage charge per box. Make check payable to SLOMA and include it in your shipment.

Shipped artwork must also include a paid UPS or FedEx barcode return shipping label within the shipping box. For any artwork without a return shipping label, SLOMA will not be responsible for return shipping, and the artist must make other arrangements.

**Pick Up / Return:** Hand delivered artwork should be picked up on Monday, March 30, 2020, 11 AM – 5 PM, or by special appointment. Shipped artwork will be returned no later than April 10. Sold artwork will be shipped at buyer's expense.

Submission of artwork to this exhibition constitutes an agreement to the conditions stated in this Call For Entry and a commitment to show accepted artwork for the duration of the exhibition. By entering this exhibition, artists agree to allow Craftmakers and SLOMA to use submitted images in promotional material. SLOMA reserves the right to reject any artwork that does not meet the standards shown in the images supplied. No substitutions are allowed.
